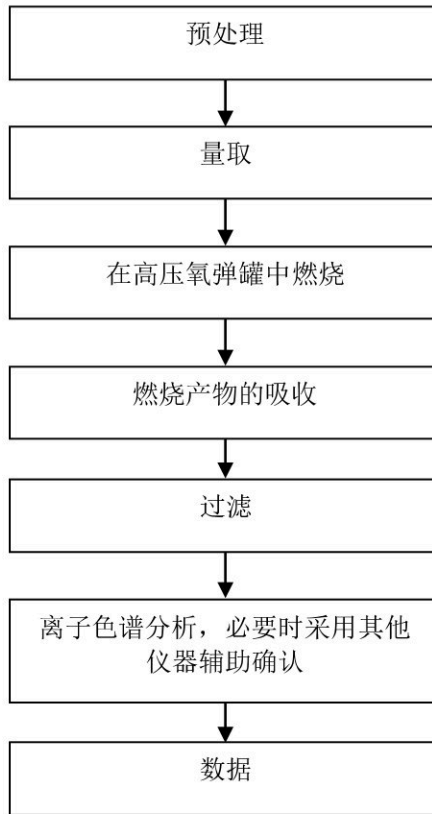

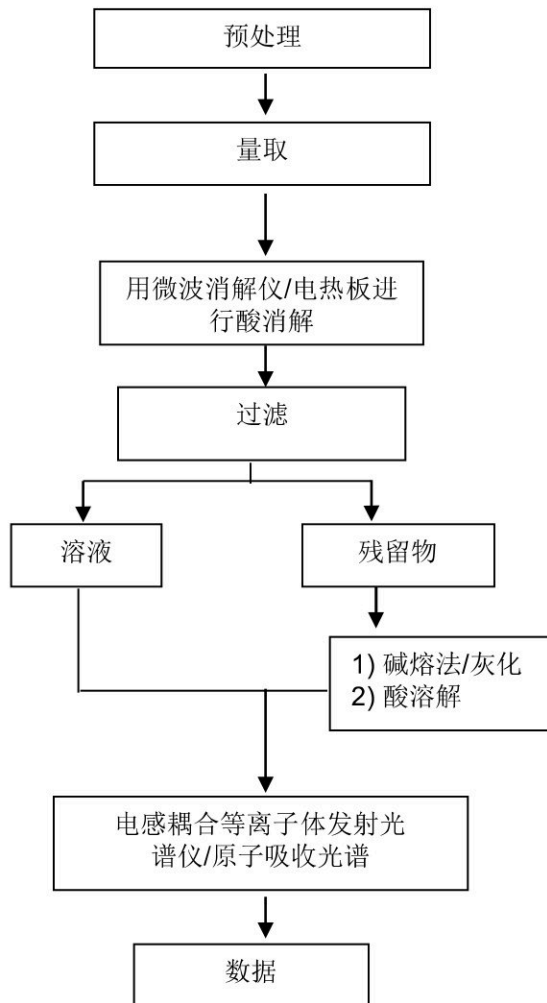
Halogen(氧弹法)测试流程图



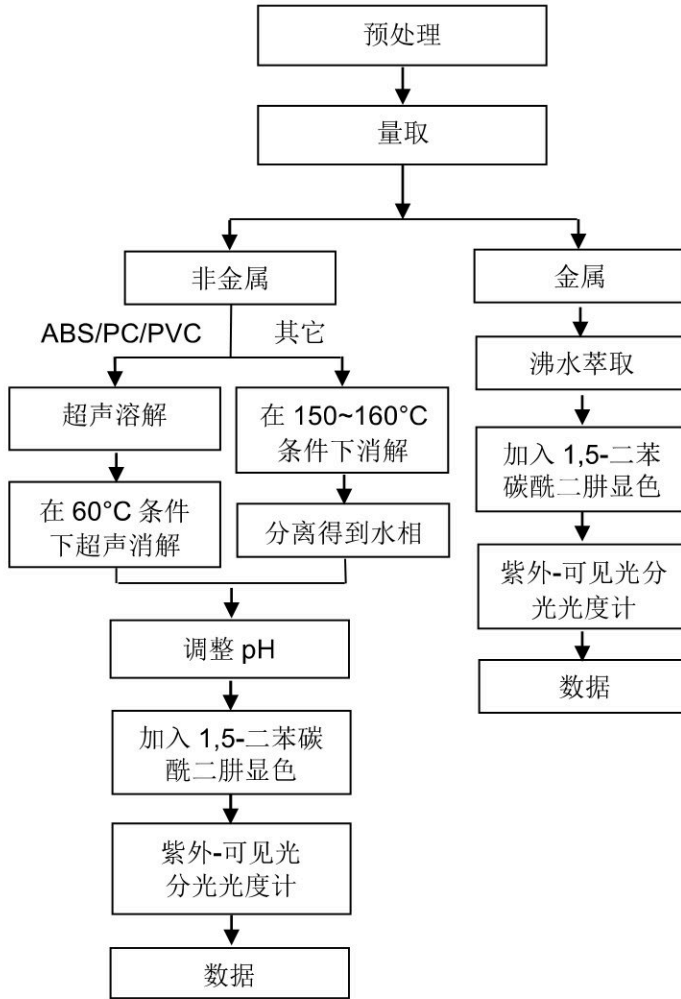

1) 样品按照下述流程被完全消解



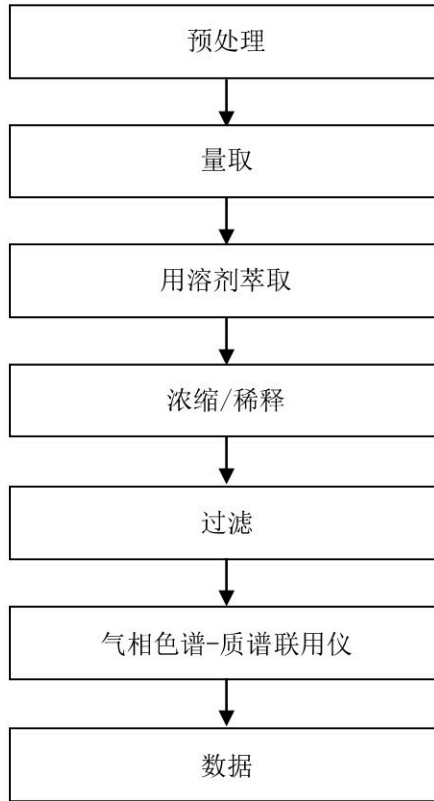
六价铬测试流程图

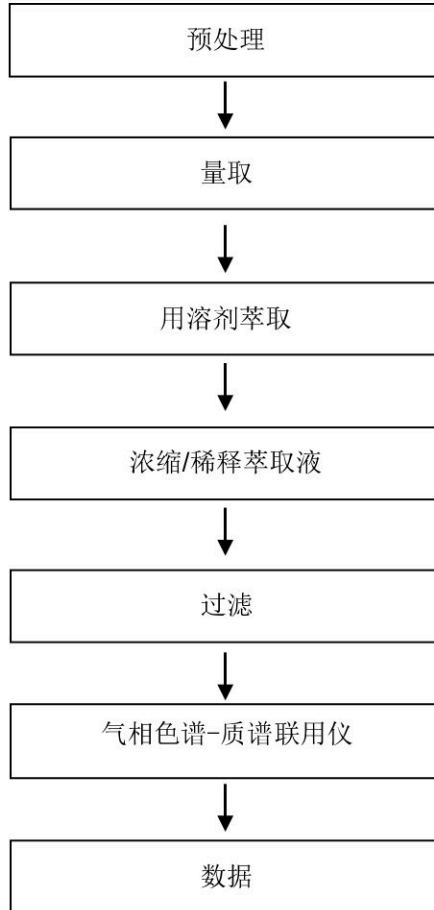
